2019 PROPOSED BUDGET

Attached is the Proposed 2019 CAL FIRE Local 2881 budget prepared at the budget preparation meeting in August 2018 and approved by the Executive Board at their September 2018 meeting.

- In following policy Section 1120.12 which states, "Resolutions pertaining to employee compensation (Policy 0350.01) and contract labor pay (Policy 0351.01) are not permissible," the executive board addressed employee wages/benefits and contractor services at the July board meeting pursuant to Sections 350.01 and 351.01 of the CAL FIRE Local 2881 Operating Procedures Handbook which read:
 - 350.01 "The compensation and benefit package for the CAL FIRE Local 2881 employees shall be established by the executive board at their July executive board meeting. Modifications shall be incorporated by the pre-convention finance committee into the appropriate line items in the initial budget presented to the convention."
 - 351.01 "CAL FIRE Local 2881 Executive Board shall, at their July executive board meeting, review and set the amount paid for contract labor services (reference Section 1255.17). Modifications shall be incorporated by the pre-convention finance committee into the appropriate line items in the initial budget presented to convention."
- Employee & Contract Services Compensations: By policy, the compensation set for employees and contract services is done in confidentiality by the executive board at the July 2018 meeting that resulted in an increase to the employee and contract services line items. The Executive Board action in July 2018 resulted in an increase to the employee and contractor line items, (548) Wages, (549) PR Taxes, (551) Benefits and (556) Contractor Services \$39,330 cost.
- In the July executive board meeting, in order to meet the continued increase in the
 demand for legal defense, the executive board voted to eliminate the Office Technician
 position and convert the legal work load into a newly created paralegal position. The cost
 of this new position will be covered from the legal line item. The money available from
 the former Office Technician will be utilized to offset the employee increases this year
 only.
- As a result of the action above relating to the employee and contractor services, the proposed 2019 budget reflects no dues increase to line items 548, 549, 551 and 556.
- The budget preparation meeting representatives incorporated the board's actions into the 2019 Proposed budget.
 (This action generated no dues increase to the 2019 Base Proposed budget.)
- The approved "Proposed Budget 2019" is based on a dues amount of \$120.50. During 2018 mid-year pass-through increases in CPF and IAFF per capita amounts of \$.28 and \$.98 respectively had changed the CAL FIRE Local 2881 current dues to \$120.50 per

- month. CPF increase is based on the CPF per capita due to an increase of .28 cents incurred from the automatic increases of CPI. IAFF increase is based on the IAFF per capita due to an increase of .98 cents incurred from the automatic increases of CPI.
- After much discussion, the budget preparation meeting representatives evaluated the average monthly and yearly membership counts and determined that an increase was not warranted. The average membership calculations to what a penny is worth remained at the base calculation of \$570.00 year. This is the equivalent of 57,000 member months annually, or 4,750 members per month. This basis accounts for a period of 36 months with some augmented staffing, reductions (loss of a contract) and no guarantee of future augmentation. The adjusted member number was based on the most appropriate business practice for our budget cycle and was in full agreement by all attendees of the meeting.
- Again, this Proposed 2019 budget reflects <u>no dues</u> increase.
