To: All State Officers, DVP's & Chapter Directors

Date: 10/3/2018

Re: Convention Registration Information

**Delegate registration:** The biggest problems regarding registration are spelling, duplicate registrations & refunds.

**Spelling** needs to match the membership database, i.e., Joseph H. Smith. Joe, Joey, or Jose on the registration form will not match when we do the search.

**Duplicate registration** end up with a refund and bad credentials for the floor. I'll use Dennis Nelson as an example. If Dennis is coming for his chapter, district, and PAC, we need clear definition on both forms of his delegate status and who is paying. In addition to being a delegate you must be a member in good standing, which applies to retirees as well.

**<u>Refunds</u>** tend to gum up the machine. When you discover that you have a refund, **PLEASE** submit it in writing. A written request will give our convention finance an opportunity to review it and the request will provide supporting documentation for the refund check.

**Printed** credentials are only necessary to validate your access to the floor as a voting member of your delegation. This means guests, vendors, VIP's, etc., will not be receiving an I.D. Badge.

## Hotel Registration - What's Different

<u>On behalf of our finance director, executive assistant, your individual treasurers and convention</u> <u>finance, PLEASE make a special effort to maintain a clean & separate document trail</u>. **Only** Paul Van Gerwen and Doug Mackey will have authorization for "master account" charges. Your room charges will be made to your credit card and expensed through the Certify program. If you need to file for a travel advance, you can do that through Certify (cash advance).
